SWEARING-IN CEREMONY FOR THE CARSON CITY ELECTED OFFICIALS - Mayor Teixeira called the meeting to order at 9:30 a.m. by explaining the purpose of the special session. Mayor Teixeira thanked all the individuals who had run for an office for their interest and willingness to participate. He urged all those who were elected to work together as a team and to communicate with each other. He was looking forward to the opportunity of working with all of the newly/re-elected individuals.
